Subject: IT return and Form No. 26AS of all Directors of Coal Transportation Companies.

Reference is invited to Note No. 1784/DGR/SE-2/Coal/IT Return & Form 26 AS dated 17.09.2015 on the above mentioned subject. The Directors of all ESM Coal Loading and Transportation Companies sponsored under Guidelines on Formation and Running of Ex-Servicemen Coal Transport Companies of 2013 are required to submit Form 26 AS as per the provisions contained in Para 20 (C) of these guidelines.

2. Approval of the Competent Authority is hereby conveyed to make submission of Form 26 AS mandatory for Directors of all ESM Coal Loading and Transportation Companies sponsored under Guidelines on Formation and Running of Ex-Servicemen Coal Transport Companies of 2007. The submission of Form 26 AS is henceforth mandatory every year with effect from FY 2015-2016 in respect of all companies sponsored under guidelines of 2007. The first Form 26 AS will be submitted by these companies by 30 June 2016.



**SUBMISSION OF FORM 26 AS**

1. As per Para 20 (c) of Guidelines on Formation and Running of Coal Loading & Transportation Companies, in order to ensure and verify the employment status of the Directors of the ESM Company, the Directors are to submit form 26 AS each year by 30 Jun to DGR/or as and when asked by the DGR.
2. Recently an allegation has been received in this Office that some of the Forms 26 AS submitted by the Directors of the ESM Coal Loading & Transportation Companies are doctored. The aim of getting Form 26 AS is to ensure that the Directors focus on running their companies and are not employed elsewhere. In case Forms 26 AS are doctored, not only the aim is defeated but the same also brings disrepute to the individual ESM(O), DGR, MoD & general ESM community at large.
