1. The Govt of India, MoD vide letter no. E/14459/Ex-Ser/04/OS-4H/726(DO-II)/2015 dated 05 Aug 2015 has approved inclusion of the following New Generation Vehicles as part of the Class V Surplus 'B' Vehicle Scheme :-
